## Redback bites back at power

A homegrown smart battery firm says it is helping people save thousands of dollars on their power bills amid a cost of living blowout.

Redback Technologies chief technology officer Adrian Knack says the Indooroopillybased company's home battery systems convert and store electricity generated from rooftop solar panels for use when the sun isn't shining.

Knack (illustrated) says the technology allows consumers to be less dependent on the grid in the face of sharp rises in power bills in a volatile energy market.

"As power prices, inflation, and cost of living expenses increase, unfortunately solar feed-in tariffs have fallen in southeast Queensland," he says. Redback was founded in 2015 by a handful of clean-tech enthusiasts dedicated to the transition to renewable energy in Australia. Knack says all of Redback's systems are designed and tested in Australia to withstand our harsh climate and conditions.

He claims that installing a home battery system together with a new solar system means consumers are generating impressive savings from switching to clean, green energy.

Knack adds that with warnings the power grid will battle to cope with demand this summer, the batteries provide a back-up option that allows them to operate – for up to weeks in some cases – in the event of a blackout.

Data released by the federal

government shows households with rooftop solar panels can save more than \$1000 a year on their electricity bills and double that amount with a home battery. Knack says some Redback customers with a right-sized home battery system are achieving rates of more than 100 per cent self-sufficiency. "This means they are producing more power than they're using and are able to export some back to the grid," he says.
